**UIL CONSTITUTION & CONTEST RULES**

SECTION 1102: (h) (1): "Conferences. The UIL will assign participating schools to a conference based on school enrollment. "

SECTION 1102: (h) (2): "Middle Schools. Middle schools will participate under the provisions listed in Section 1400 and are assigned to conferences according to the following:

- (A) Conference 1C Middle School. Enrollment of 0-249 in grades 7 and 8.
- (B) Conference 2C Middle School. Enrollment of 250-649 in grades 7 and 8.
- (C) Conference 3C Middle School. Enrollment of 650 or more in grades 7 and 8."

SECTION 1102: (h) (5): "Corrections To Middle School ... Conference Assignments. Corrections to middle school ... conference assignments will be accepted up to 30 days prior to the first day of the first region music contest or event of the school year for that conference. Corrections should be submitted in writing to the Region Executive Secretary by the school principal (or designee)."
